

ISO 17021 is the Standard certification bodies must follow for Certification Audits:

A Stage 1 audit seeks to confirm the existence of a documented system addressing requirements of the appropriate standard, and to establish a level of confidence that the auditee has an operating system that meets at least the minimum requirements of the standard in question. Stage 1 will also evaluate the implementation of selected subsystems such as auditing and improvement.

A Stage 2 audit examines detailed operational elements of the system and determines if the way the system is operating is effective in delivering the overall aims of the organisation as well as satisfying the standard.
